SUMMARY STATEMENT

On the second year of the existence of the Philippine League Against Epilepsy, the activities mostly pertained to refining and amending certain details of the constitution., formulating the mission and vision of the organization, creation of working committees and obtaining recognition from the mother organization, the International League Against Epilepsy. Aside from these, the PLAE initiated interactive sessions with its members in the form of case discussions and lectures.
